**Organization:** Profit or Non-Profit legal entity (business, church, hospital, Service Club, Boy Scouts..)

**Employer:** A resource or organization that offers job-experience and/or pay (store, agency..)

**Group:** Generally an informal and on-going group of people who meet (family, friendship, study, hobby, volunteer..)

**Neighborhood Group:** Proximal adults & youngsters who do activities together (for fun, friendship, projects, seasonal get togethers..)

**Individual:** One person who would like to be a wholesome resource to a youngster (mentor, coach..)
